 'Seller' means Almatis Limited.
- Unless specified otherwise, terms defined in the 2020 Edition of INCOTERMS shall have the same meaning when used in these Conditions. INCOTERMS selected by Seleter shall apply and is deemed to form part of the Contract, provided however that should there be conflict between the applicable INCOTERMS and the provisions of the Contract, the 1.2

Unless expressly agreed in writing, these Conditions apply to all sales of the Products by Seller and, with the Contract, contain the entire agreement in connection with the Products. PRICE & PAYMENT

- Unless otherwise agreed by Seller in writing, the prices payable shall be those stated on Seller's order acceptance or invoice and all prices quoted are exclusive of VAT and any other duties, fees and taxes. All sums due to Seller shall be paid in the currency and to 3.1

RISK AND TITLE

Buyer shall sell, use or part with possession of the Products only in the ordinary course of trading and shall store the Products separately from all other goods and clearly identified as Seller's property.
